all by these presents, that the undersigned, William G. Quigley, III, hereby makes, constitutes and appoints Stacy L. Fox and Heidi A. Diebol, and each of them severally, as his true and lawful attorneys-in-fact, with full power and authority as hereinafter described on behalf of and in the name, place and stead of the undersigned to:
