WITHDRAWAL OF SECURITIES FROM REGISTRATION

On June 26, 2000, Visteon Corporation (the “Company”) filed a registration statement on Form S-8 (Registration No. 333-40202)(the “Registration Statement”) with the Securities and Exchange Commission registering 13,000,000 shares of the Company’s Common Stock, par value \$1 per share (the “Old Common Stock”), to be offered or sold pursuant to the Visteon Corporation 2000 Long-Term Incentive Plan (renamed the Visteon Corporation 2004 Incentive Plan, the “Plan”).

On October 1, 2010 (the “Effective Date”), the Company consummated the transactions contemplated by the Fifth Amended Joint Plan of Reorganization of Visteon Corporation and its debtor affiliates pursuant to Chapter 11 of the United States Bankruptcy Code, as filed on August 31, 2010 (the “Plan of Reorganization”). In accordance with the Plan of Reorganization, the Old Common Stock was cancelled as of the Effective Date.

As a result of the consummation of the transactions contemplated by the Plan of Reorganization, the Company has terminated all offerings of the Company’s securities pursuant to the Plan and Registration Statement. Accordingly, the Company is filing this post-effective amendment No. 1 to the Registration Statement to withdraw from registration all remaining unissued shares of Old Common Stock under the Plan and Registration Statement as of the Effective Date.
